Initial \_\_\_\_\_ This agreement is made for the benefit and protection of both the Buyer and the Seller. Seller guarantees this puppy to be free of hereditary and genetic defects for the first 26 months of age. Should the poodle develop a scientifically proven genetic disease that is confirmed by two licensed veterinarians during this time, the Breeder shall replace the poodle with a puppy of the same value (or the difference can be paid by the buyer). If the poodle has been bred before the defects have been found, this guarantee is null and void.

Initial \_\_\_\_\_ The Breeder warrants that the puppy is in good health and free from communicable and non-communicable diseases at the time the Buyer takes delivery. The Breeder shall provide the Buyer with the puppy's inoculation record upon delivery. The Breeder offers a 72 hour well-puppy health guarantee. This means that the Buyer must take the puppy to a licensed veterinarian for a well-puppy check-up within 72 hours of possession. If the veterinarian diagnoses the puppy with any untreatable illnesses, a replacement puppy of same value (or Buyer can pay difference) will be given with the return of the first puppy (at Buyers expense). All papers shall be returned as well as proper signatures for transfer. No veterinary or shipping costs will be reimbursed by the Breeder.

Initial \_\_\_\_\_ The poodle's sire and dam are both certified as free, at the time of breeding, of hip dysplasia, genetic eye disorders, thyroid disease, genetic cardiac abnormalities, and von Willebrand Disease. We have done our best to ensure that your poodle will be free of hereditary disease.

Initial \_\_\_\_\_ The Buyer agrees to provide this puppy with proper vet care, diet, housing, socialization, and grooming for his/her entire life. The puppy should be groomed approximately once a month or more often if necessary. The Buyer agrees that if at ANY time in this puppy's life, the Buyer is unable to keep him/her, that the puppy is returned to the Seller or lets Seller know first that they are unable to keep it. Under NO CIRCUMSTANCES shall this puppy be placed into a shelter, a pet store, placed with a rescue organization or foster care. The Seller will take the puppy back or help find him/her a new home at any time during its life.

Initial \_\_\_\_\_ The Breeder agrees to be available for help throughout the entire life of the dog. The Breeder maintains a continuing interest and pride in this dog and in its accomplishments. Any phone calls, letters, photographs, updates, etc will be much appreciated.

Initial \_\_\_\_\_ The Buyer agrees NEVER to use the poodle for breeding NON-AKC registered poodles or mixed breed dogs (including but not limited to Labradoodles, Goldendoodles, merle or other poodle mixes). This agreement extends over the entire life of the dog even after the Buyer has received sole ownership registration papers. Should the Buyer use, or allow the poodle to be used, for breeding NON-AKC registered poodles or mixed breed dogs, legal remedy will be sought, and the Buyer will pay the Breeder \$10,000 plus any and all expenses, including but not limited to attorney fees, as compensation for damage to the Breeders reputation. The Buyer will also forfeit ownership and will ship, at the Buyers expense, the poodle to the Breeder.



#### TERMS OF REGISTRATION WITH AKC

Initial \_\_\_\_\_ The registered name will contain the breeder's kennel name, "OMG's". The Buyer will be given all paper work necessary for AKC registration depending on what rights are being purchased (pet, breeding/showing or temporary limited). All registration fees to AKC will be paid by the Buyer.

\_\_\_\_\_ Limited Registration Contract (AKC Limited Registration)  
\$2500.00

This poodle is sold as a companion. It is NOT to be used for breeding (intentionally or unintentionally). The Buyer agrees to have the poodle spayed/neutered between 18 to 24 months old.

\_\_\_\_\_ Full Registration Contract (AKC Full Registration)  
\$3000.00

This poodle is considered to be breeding/show quality. The following conditions will be met before the dog is bred

1. Poodle has completed his/her AKC or UKC Breed Championship OR he/she has achieved at least one performance title. (i.e agility, rally, obedience, agility)

2. Poodle has normal and satisfactory test results for at least the following: hips, elbows, eyes, cardiac. The Buyer agrees to pay all costs associated with showing, competing and testing said poodle.
3. Poodle is of appropriate breeding age.

THE BUYER AND SELLER HAVE THOROUGHLY READ AND UNDERSTAND AND AGREE TO ABIDE BY THIS CONTRACT.
