

### Non-Refundable Puppy Reservation Fee Agreement

This agreement ("Agreement"), dated as of , 20  (the "Effective Date"), is between **Meagan Townsend** ("Breeder"), and  ("Buyer"). Buyer agrees to place a **\$500.00 Reservation Fee** on a Standard Poodle from Breeder.

1. **Non-Refundable Reservation Fee (RF).** Buyer acknowledges that the RF is non-refundable in all circumstances, including but not limited to, if Buyer decides s/he does not want or is no longer able to take the puppy. Upon receipt of the RF, Breeder agrees to hold the Buyers spot on the desired litter's reservation list until picks at approximately 8 weeks of age. Breeder then agrees to hold the puppy for Buyer until 10 weeks of age when the puppy is ready for pick up. RF shall be made in US Dollars and paid to Breeder via payment through Good Dog Breeder Center. Breeder will also take checks mailed to PO Box 822, Manassa CO, 81141. Spot on list will be granted upon check clearing breeder's bank.
2. **Buyer Acknowledgements.** Buyer further acknowledges and agrees that (a) Breeder cannot control litter sizes and that the wait time for puppies can be longer than expected; (b) the RF gives Buyer a place on the litter's list in the order of RFs received, but does not guarantee a puppy or that Buyer's preferences will be available when it is the Buyer's turn to pick; (c) pick places are given on a first-come first served basis and Buyer's place in line is not negotiable; (d) Breeder cannot and does not guarantee any specific qualities of the puppy when it becomes an adult. (e) Breeder will help match puppy to Buyer based on temperament. Puppies all go through the APET temperament test administered by a professional trainer, at approximately 8 weeks of age. Puppies will be placed in the home based on the results of the test and the answers given in the puppy application and interview. Other preferences such as sex and color will be taken into consideration but will not take precedence. (f) If Buyer is found misrepresenting information on their application or in the interview about intentions, plans, desires with puppy or any other information, Buyer will forfeit RF and will be removed from current and all future lists indefinitely. (g) Puppy is not planned nor will ever be used in a mixed/doodle breeding program.
3. **Buyer's Right to Transfer.** if a puppy that meets Buyer's identified preferences is not available [when it becomes Buyer's turn to pick a puppy from the selected litter], Buyer may elect to have the RF transferred to the next litter]
4. **Final Purchase Price** Breeder and Buyer agree that (a) the RF shall be applied to the final purchase price of the puppy and (b) the remaining balance will become due before the puppy is shipped and/or ownership is transferred from Breeder to Buyer. [The total purchase price for the puppy is \$2500.00. The foregoing purchase price does not include any delivery or shipping charges.]
5. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Colorado without regard to the conflicts of laws provisions thereof.
